This letter is in response to your Freedom of Information Act email request dated March 21, 2010 and received March 22, 2010. You requested the ages of all Southwestern competitive service employees and employee award percentages under 2.0 for organizations 6100, 6200, and 6300, over the age of 40 and under the age of 40.


A redacted copy of the ages of all Southwestern competitive service employees is enclosed pursuant to Exemption 6 of the Freedom of Information Act, 5 U.S.C. 552(6) and 10 C.F.R. 1004(b)(6).

A redacted copy of the award percentages under 2.0 of organizations 6100, 6200 and 6300, over the age of 40 and under the age of 40 is enclosed pursuant to Exemption 6 of the Freedom of Information Act, 5 U.S.C. 552(6) and 10 C.F.R. 1004(b)(6), the Departmental regulations implementing FOIA.

Exemption 6 authorizes the withholding of personal information of individuals found in "personal and medical and similar files" where the disclosure of such information would constitute a clearly unwarranted invasion of personal privacy.

Pursuant to 10 C.F.R. 1004.10(b)(6), Southwestern has determined that some of the information is exempt from mandatory public disclosure. The Freedom of Information Act Regulations at 10 C.F.R. 1004.8(a) state that you may appeal the decision to withhold this information. Such appeal must be made in writing, within 30 calendar days of the receipt of this letter to the Director, Office of Hearing and Appeals, Department of Energy, 1000 Independence Ave., S.W., Washington, DC 20585-0107. If after your appeal to the Director you believe a further appeal is necessary, then judicial review in a district court will be available either with the district in which you reside or in the District of Columbia.
