Dear Mr. Pahel:

This is in response to the request for documents that you sent to the Southwestern Power Administration under the Freedom of Information Act (FOIA) 5 U.S.C. 552. Specifically you requested a breakout of the bidders names and their bid amounts on DE-SOL-000163.

Enclosed are copies of the information you requested. However, information has been redacted under Exemption 4 of the FOIA. 5 U.S.C. Section 552(b)(4), 10 C.F.R. Section 1004.10(b)(4), protects trade secrets and commercial or financial information obtained from a person and is privileged or confidential.

Information required to be submitted by a person is confidential for purposes of Exemption 4 if disclosure is likely to either (1) impair the Government's ability to obtain necessary information in the future or (2) cause substantial harm to the competitive position of the person from whom the information is obtained.

Portions deleted from the documents enclosed contain information that relates to the identity of the bidders as well as to business activities. Information would give competitors an advantage in the future by providing insight to resources available to the submitter and the method used to respond to a solicitation. The release of confidential client information would also cause substantial harm to the firm's competitive position. For these reasons, the information is being withheld.

Pursuant to 10 C.F.R. 1004.7(b)(2) I am responsible for the determination to withhold the information under Exemption 4 of the FOIA.

Likewise, pursuant to 10 C.F.R. 1004.8, you may challenge the determination to withhold information from the document by submitting a written appeal to the Director, Office of Hearings and Appeals, L'Enfant Plaza Building, U.S. Department of Energy, 1000 Independence Avenue, S.W. Washington, D.C. 20585-1615.

The written appeal, including the envelope must clearly indicate it is a FOIA Appeal. The appeal must contain all elements required by 10 C.F.R. 1004.8 to the extent applicable. Judicial review will thereafter be available to you (1) in the District of Columbia, (2) in the district where you reside, (3) in the district where you have your principal place of business or (4) in the district where the DOE records are located.
